## Payment of Dues

If you are a member of the CBA a bill for both the CBA and BCBA will be sent to you by the Colorado Bar Association in June. If you are a member of only the BCBA, the dues are billed as follows.

A “year” begins on July 1<sup>st</sup>, and ends June 30<sup>th</sup>. Dues are prorated quarterly.

If you are joining:

Between July 1 <sup>st</sup> and September 30 <sup>th</sup>	--	Pay full dues
Between October 1 <sup>st</sup> and December 31 <sup>st</sup>	--	Reduce dues by 25%
Between January 1 <sup>st</sup> and March 31 <sup>st</sup>	--	Reduce dues by 50%
After April 1 <sup>st</sup>	--	Reduce dues by 75%

If you choose to pay with your application and are joining both the CBA and BACA, please make a check payable to the Colorado Bar Association; if you are paying just for the BCBA, please make a check payable to the Boulder County Bar Association.
