SHAPING OUTCOMES

I recently finished reading Bryan Stevenson's book *Just Mercy*, which is a vivid account of his legal career defending death row inmates, juveniles incarcerated for life, and the mentally ill. Afterward, I spent some time berating myself for failing to use my law degree on issues of life and liberty. I considered taking on a pro bono criminal case. Then, I circled back to that ever-present, nagging question: "Wasn't I likely to do more harm than good by venturing outside the intellectual property world?"

In my experience, patent attorneys and agents have shied away from pro bono work because opportunities within their field have been practically non-existent, and branching out brings into play legitimate concerns of ineffectively assisting clients and committing malpractice.

Enter, the United States Patent and Trademark Office (USPTO) Patent Pro Bono Program, implemented as part of the America Invents Act. This program offers patent attorneys and agents the chance to make a difference in the lives of inventors with limited means, while working within the practitioner's area of expertise. And, judging from the numbers reported by the USPTO earlier this month, practitioners are embracing the opportunity. In the past six years, over 800 attorneys and agents nationwide have participated in the program.

In the Rocky Mountain region, the USPTO program is administered as the Pro Bono Patent (ProBoPat) program out of the Mi Casa Resource Center in Denver, Colorado (which also conveniently offers training programs and resources for entrepreneurs).

Jennifer Rothschild, the director of the ProBoPat program, explains that most of the inventions are mechanical devices, such as household goods and

tools, so there is always an available client for a patent practitioner willing to help. Literally, five minutes of phone or e-mail time is all that is required to match a practitioner with an inventor from the waitlist. After speaking with the inventor, the practitioner chooses the level of commitment, from searching to application drafting to prosecution. This flexibility is meant to induce volunteer participation, at any level, because even one patentability search a year provides a huge benefit to a client. The search not only indicates the availability and potential scope of patent protection, it informs the client's decision about "putting skin in the game" because inventors are required to pay all USPTO fees. Torrey Spink of Kilpatrick Townsend & Stockton LLP has helped a number of inventors over the years, including one who borrowed money from friends and family to pay for Track I expedited examination. That patent is now issued, and the client is making and selling the patented product. It's a rapid success story, but Torrey's motivation runs deeper. He enjoys working with inventors from the ProBoPat program because they're passionate about their products, they believe in themselves, and they're bravely pushing past socioeconomic barriers. He sums all this up by saying, "It's nice to help people who have dreams."

Tiffany Parcher, an in-house patent attorney at Medtronic, participates in the ProBoPat program to help her community, to keep her skills fresh, and to maintain direct client interaction. She enjoys the enthusiasm and gratitude of the individual inventors, whom she says "give you more credit than you deserve," and her pro bono work increases her appreciation for aspects of her corporate job, such as the ability to quickly discuss complex issues

using shorthand “patent-speak”. Tiffany is able to experience both work perspectives thanks to the Association of Corporate Counsel (ACC), Colorado Chapter, which provides liability insurance for its members’ pro bono activities as part of membership dues.

Other organizations also support pro bono work. Torrey’s law firm, for example, credits some of his pro bono hours toward his billable hour requirement, and the Colorado Supreme Court awards one hour of general CLE credit for every five hours spent volunteering up to a maximum of nine hours per three-year reporting period (CRCP 260.8). Of course, one reason for volunteering in the ProBoPat program overshadows client enthusiasm, skill maintenance, reduced billable hours or CLE

credit. It is summed up in a paraphrased sentence from *Just Mercy*: “Wealth ... shapes outcomes.” Although the outcomes for IP clients may be less consequential than those for Mr. Stevenson’s clients, **each volunteer patent attorney is offering an opportunity usually reserved for the wealthy to an under-served person, which could shape the outcome of that person’s life.** To volunteer for the ProBoPat program, contact Jennifer Rothschild at 303-539-5643 or by e-mail at probopat@micasaresourcecenter.org.
