SCHOOL SUPPLIES DONATION DRIVE

The Boulder County Bar Association is teaming up with the St. Vrain Valley Schools Education Foundation in supporting a school supply distribution that ensures over 4,700 students in St. Vrain Valley Schools start the school year with the supplies they need for a successful and strong academic year. We are hoping our members can show their support by providing very much needed supplies: school backpacks and wide ruled comp books or wide ruled spiral notebooks. These are





very specific supplies needed at this time, so these are the only two items we will be collecting.

Backpacks should be basic with at least 15-18 inches in size with no other accessories (water bottles, lunch boxes, pencil bags, etc.) Wide ruled comp books or spiral notebooks should be 100 pages or less. These specific requirements help to ensure equitable distribution to all schools.

We will be collecting the requested backpacks and notebooks at the BCBA office throughout the month of June. Please contact Kyle with further questions or to arrange drop-offs at the office.

We are also planning to participate on at least one date in July where we meet at the Education Foundation's distribution site, Trail Ridge Middle School (1000 Button Rock, Longmont), where we help stuff the donated backpacks with notebooks and other school supplies to prepare them for the student recipients. Our next event for the Paralegals/Legal Assistants section is a section lunch on June 27 at 12:00 pm at






