It is estimated that eighty percent of low income people have trouble securing representation in court for matters ranging from property/home foreclosures to family law to wage disputes to public benefits. The annual JUSTICE FOR ALL BALL donates all proceeds to Boulder County Legal Services to assist with their representation of families and individuals who otherwise could not afford an attorney. This year, the JUSTICE FOR ALL BALL will be held at The Boulder JCC on Saturday, April 1. Jackson Women's Health Organization* impacts everybody and is having long reaching effects into Colorado, even if the right to make abortion and healthcare decisions has remained stable in our home state. This informative program will educate attorneys in many different practice areas about the state of reproductive health care in Boulder and Colorado after the *Dobbs* decision and will look at what the future holds. The presenters will be Professor Jennifer Hendricks (find her CU faculty page [here](#)) and Jack Teter, Policy Director of Planned Parenthood of the Rocky Mountains. You may not know this, but the BCBA Board and officers work on a July to July calendar rather than the traditional annual calendar. I must also, regretfully, share news of the passing of Judge Kristy Martinez on February 21, 2023. Judge Martinez was appointed to the Boulder bench in 2018 by then-Governor Hickenlooper. She was retained during the recent general election to continue on the bench but unfortunately, was unable to fulfill that role. Judge Martinez began her legal career as a deputy

district attorney in Adams County and was also a law professor at CU teaching Post-Conviction Criminal Procedure and Wrongful Conviction. She was the director of the law school's Korey Wise Innocence Project. I did not have the pleasure of ever being before Judge Martinez in her courtroom, but the outpouring of comments about her speaks volumes about who she was as a person and as a judge. Reading the words written about Judge Martinez, people described her as a "mentor," a "fighter for justice" with a strong "moral compass," and that this "world is a sadder place without her." All of us at the BCBA share our deepest condolences to her family, friends and all who knew Judge Martinez.

MOCK TRIAL COMPETITION TEACHES YOUTH ABOUT THE LEGAL SYSTEM

"I cross-examine my brother now!" said high school student Ellie Musfeldt laughing. We all can agree that questioning skills gained as an attorney are invaluable in our profession as well as in life outside the courtroom. What was apparent in speaking with Miss Musfeldt and many other high school students that participated in the mock trial competition in Boulder County was the enthusiasm the students had for learning about the legal system and the confidence they gained by public speaking in the courtroom. This unique program sponsored by the Colorado Bar Association is now in its 38th year and continues to encourage our youth to become engaged in the legal process.

Every year, hundreds of high school students spend months working on a detailed case problem which alternates between criminal and civil fact patterns. The students competed as teams by presenting their case as either the prosecution or defense in this year's criminal case with team members performing both as lawyers and as witnesses. Attorneys and members of the community volunteer to judge the competition at both the county and statewide level. The time and preparation that the students put into the competition is obvious to the scoring judges and the presentations of evidence are well thought out, articulate and entertaining to watch. "The Bar Association comes up with cases that are relevant and related to current events in the real world," said high school student Olaya Garcia-Grau when commenting on this year's case problem which was a criminal prosecution of a parent that



allegedly bribed a college for the admission of their child.

The mock trial program encourages high school aged students to become active participants in the legal system in a way that allows them to see some of the inner workings of how justice is served. Not every student that participates will go on to become a lawyer, but all of the students that participate gain valuable critical thinking and public speaking skills. Felix Feiger, a high school participant, described some benefits from participating in the program as follows: "A big skill that you can apply to the rest of your life is making a connection with people that you've never met before. It's about making a connection with the coach, the team, and the jury to get people to see ideas from your point of view and perspective." Eva Batlle, also a high school student, commented that the program "helps you think on your feet more." "It focused us to think of more creative ways to prosecute the case," said high school

student Keerthana Baleji. "It helps teach perseverance" said high school student Carter Squirrel. Coby Horowitz, a high school student, commented that the mock trial program teaches "how law works in general, how trials are done, the general structure."

Having seen the students present their evidence in the Boulder County courthouse this year and their enthusiastic high-fives to each other afterward, it was clear how much these students have come together as teams in this non-sporting event. "It is about team work and helping each other," said

high school student Annabelle Eisner. Kate McCall, also a high school student, echoed her sentiment by stating that "working together with your team" was one of her favorite parts of the program. If you have the opportunity to volunteer in any way to promote this program, I whole-heartedly encourage you to do so. To see the legal process being tackled by teenagers is an invigorating experience. The courtroom decorum of these youth and their ability to handle objections coming on many (perhaps some non-objectional) questions is inspiring.

REMEMBERING JUDGE MARTINEZ

Judge Kristy Martinez, 53, of Lafayette, Colorado passed away peacefully the morning of February 21, 2023 from cancer.

Kristy was born in October 1969 to Sally Wear and Ralph Clayton Sieg in Washington, where she grew up. Kristy later moved to Colorado to attend the University of Denver. She received a B.A. in Human Communication from the University of Denver in 1995.

While working full time, Kristy attended law school at night until she earned her Juris Doctorate from the University of Denver Sturm College of Law in 1999. This began what Kristy described as a love affair with the profession within which she would spend the rest of her life. Kristy embodied what some might see as an old-fashioned conception of what it means to be a lawyer—she believed it was a noble calling, answered by people in pursuit of high ideals of fairness and justice.

Kristy was one of the rare Colorado attorneys who answered that calling on both sides of the criminal justice system. She began her career as a Deputy District Attorney in Adams County. In 2002, Kristy established a criminal defense practice representing indigent clients at trial, on appeal, and during post-conviction review. She represented clients from difficult circumstances, including those experiencing mental illness, homelessness, lack of education, substance abuse, domestic violence, and terminal illness. Kristy had a particular talent for forging strong connections with people, no matter their background. This talent, combined with her dogged pursuit of fairness, hardworking approach to cases, and passion for the law earned her a reputation as an exceptional trial and post-conviction attorney.

While in private practice, Kristy and her then-husband Esteban Martinez welcomed their daughter—Isabella “Bella” Martinez—into their life. Kristy cherished her role as a mother and her time



with Bella. Kristy was extremely proud of Bella's accomplishments, but was even more proud of who her daughter is. She firmly believed raising Bella was the most important thing she ever did. Kristy survived her first cancer diagnosis in 2003. From that experience, Kristy developed an acute sense that each day was a gift and sought to make the most of the time she had left.

Beginning in September 2015, Kristy served as the Director of the Korey Wise Innocence Project. The Korey Wise Innocence Project provides free investigative and legal services to people serving time in Colorado prisons for crimes they did not commit. Kristy built and led a team of student volunteers to screen requests and correspond with incarcerated persons and their families seeking exoneration.

While serving as the Director of the Innocence Project, Kristy taught both Post-Conviction Criminal Procedure and Wrongful Conviction at the University of Colorado School of Law. As a

professor, Kristy instilled in students a deep commitment to fairness, fair process, and the Constitution of the United States of America. She inspired a generation of lawyers to view their role as attorneys as an awesome responsibility, while inspiring the very best growth in them. When she wasn't investigating wrongful convictions or teaching, Kristy could often be found mentoring students from all walks of life. She shaped the lives and careers of innumerable students. Her passion and enthusiasm left a longstanding mark on the law school and many of its graduates.

In 2019, then-Governor John Hickenlooper appointed Kristy to serve as a County Court Judge in the 20th Judicial District. Judge Martinez served the Boulder community with the same diligence she brought to her advocacy. She brought to the

bench a sense that the law is made up of the human beings that walk into the courtroom. She prioritized treating every person appearing in her court with dignity. She strove to make the proceedings accessible to every defendant and prose litigant. She inspired jurors with a sense of their critical role in the democratic process. She continued to mentor both lawyers and court personnel. Judge Martinez was a truly exemplary judicial officer.

Those who knew Kristy described her as energetic. She brought intensity to her professional responsibilities, but also magic to every single day—whether it was running through sprinklers or buying the biggest pumpkin she could find. She was a talented marksman with a bow and arrow, and she loved horses and hiking. She could hustle a deal better than anyone. She was a fierce and loyal friend, daughter, colleague, judicial officer, and above all, mother. She gave her very best to those around her and brought out the very best in them. She left an indelible mark on the profession, the Boulder community, and the lives of everyone she knew.

Kristy is survived by her mother (Sally Wear), her daughter (Bella Martinez), Bella's father (Esteban Martinez), and her brothers (Russell Sieg and Dale Sieg).

A celebration of life will be held in the jury assembly room of the Boulder County Justice Center, 1777 6th St, Boulder, CO on Friday, March 10th at 3:30 p.m. In lieu of flowers, the family requests donations be made to the Humane Society of Boulder Valley or an organization of your choice.

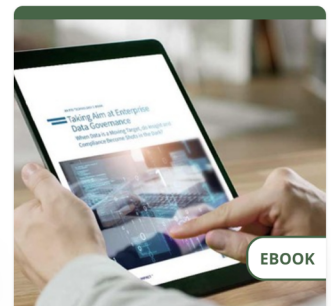

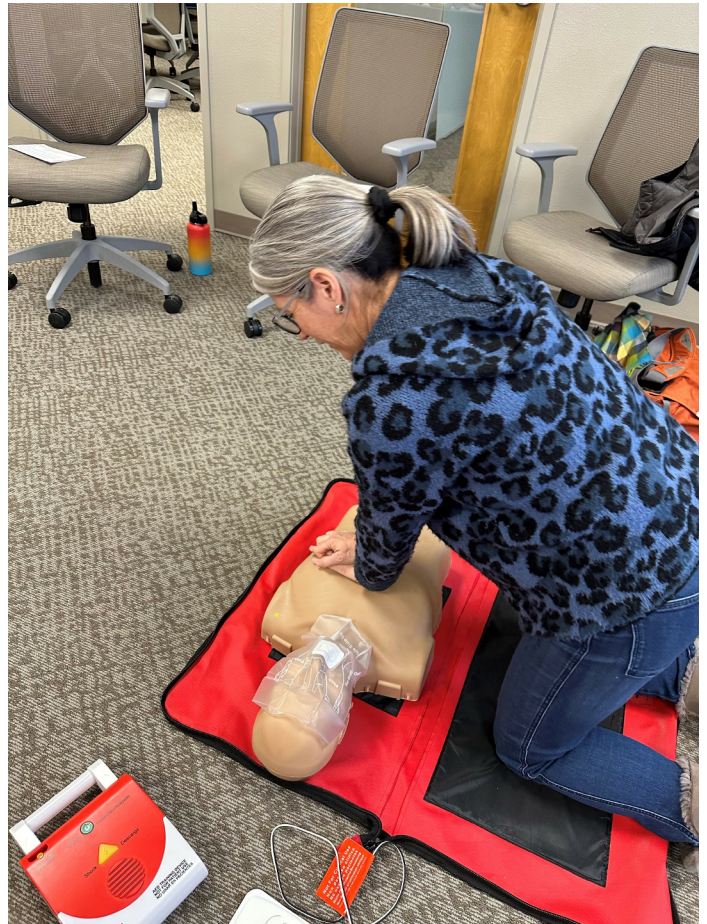
